



MUNICIPAL ORDINANCE NO. 11- S-2008

"AN ORDINANCE GRANTING ALL DISABLED CITIZENS OF BACOOR FREE ADMISSION TICKETS IN CINEMAS OPERATING IN BACOOR CAVITE".

Sponsored by Hon. Reynaldo M. Fabian

WHEREAS, the Municipality of Bacoor, Cavite desires to give privileges and incentives to its disabled citizens to make their lives comfortable, meaningful and to uplift their self esteem;

WHEREAS, unlike senior citizens of the Municipality, the disabled citizens do not receive any privileges in any form at all;

NOW THEREFORE: BE IT RESOLVED AS IT IS HEREBY RESOLVED to enact an Ordinance to read as follows :

BE, it enacted by the Sangguniang Bayan that :

Section 1. *Title* : This Ordinance shall be known as the " 2008 Free Cinema Admission Ordinance for the Disabled Citizens of Bacoor".


Section 2. *Scope* : This ordinance shall only apply to cinemas operating within Bacoor, Cavite and shall only apply to persons with disabilities.

Section 3. Person with disabilities residing at Bacoor, Cavite shall be entitled to free admission to all cinemas within Bacoor, Cavite which only be availed every Monday and Tuesday for the exclusive use or enjoyment of persons with disability, provided that this privilege may only be availed of once every Monday or Tuesday and only by the person with disability.

The above-mentioned privilege is available only to persons with disability who are permanent residents of Bacoor, Cavite upon submission of an identification card issued by the Municipal Mayor.



MUNICIPAL ORDINANCE NO. 11-S-2008 AN ORDINANCE GRANTING ALL DISABLED CITIZENS OF BACOOR FREE ADMISSION TICKETS IN CINEMAS OPERATING IN BACOOR, CAVITE" 21 July 2008, Page 2

Section 4. Budget Allocation and Compensation : To compensate the establishments affected by this Ordinance, the amount of Php 500,000.00 shall be taken from the municipal funds of Bacoor, Cavite. Should the said amount be insufficient to compensate to the establishments, the Municipal Mayor shall be allowed to draw additional funds subject to the appropriation of the Sangguniang Bayan.

Section 5. Penalties : Establishments found, after trial by the proper court, to have violated this Ordinance shall be fined Php 2,500.00 for every disabled citizen covered by this Ordinance not given the aforementioned discount during the days covered by this Ordinance.

Section 6. Implementation and Policy Guidelines : To ensure the successful implementation of this Ordinance, the Office of the Municipal Mayor of Bacoor, Cavite is hereby authorized to draw up the necessary implementing rules and policy guidelines. Copies of the said implementing rules and policy guidelines shall be furnished to the management/operator of the establishments affected by this Ordinance.

Section 7. Separability Clause : Should any provision of this Ordinance be declared void, the remaining provisions of this Ordinance not affected by the said declaration shall remain valid.

Section 8. Repealing Clause : All existing Ordinances that are in conflict with this Ordinance are hereby repealed.

Section 9. Effectivity : This Ordinance shall take effect within fifteen (15) days from its posting in at least two (2) conspicuous places at the Municipal Hall Building of Bacoor, Cavite.
