WHEREAS, the Municipal Government wishes to institutionalize the integrated youth and sports development program and envisions the continuity of its implementation that will transcend the changes in the municipal government's administration, until it is either repealed or amended in order to give way for a better sports program for the municipality;

NOW, THEREFORE, be it enacted by the Sangguniang Bayan in session assembled, upon motion of Councillor Gianne Louise Olegario

That:

SECTION 1. TITLE. This ordinance shall be known as INTEGRATED YOUTH AND SPORTS DEVELOPMENT ORDINANCE FOR THE MUNICIPALITY OF BACOOR AND CREATING THE OFFICE OF THE YOUTH AND SPORTS DEVELOPMENT COUNCIL;

SECTION 2. DECLARATION OF POLICY

- a. It is hereby declared the policy of the Municipal Government of Bacoor to promote physical education and encourage sports programs, league competitions and amateur sports including training for international competition, to foster self discipline, teamwork and excellence for a healthy and alert citizenry;
- b. Subscribing to the International Charter of Physical Educational and Sports of UNESCO, the Municipal Government believes that physical education and sports will contribute in inculcating fundamental human values underlying in the full development of a person.
- c. The Municipal Government recognizes that sports development will effectively address the need for a comprehensive grassroots sports program centered on values formation inherent in the practice of sports and play (e.g. patriotism, nationalism, self discipline, respect for law and order, hard work, teamwork, camaraderie, sportsmanship and fair play), thus, preventing a child's chances of becoming a juvenile delinquent.

SECTION 3. CREATION OF SPORTS DEVELOPMENT COUNCIL:


There is hereby created the **BACOR MUNICIPAL SPORTS DEVELOPMENT COUNCIL** ("BMSDC" for brevity) which shall act as the coordinator of all sports activities in the Municipality. The BMSDC shall encourage the establishment of associations/organizations in every field of sports discipline as may be identified by the council. At the same time, the council shall formulate plans that will not only promote the sports, but the socio-economic, education, socio-cultural and civic programs of the Municipal Government of the youth sector. The powers of the BMSDC shall be as follows:

A. Sports

1. The BMSDC shall formulate guidelines, rules and regulations for all sports programs for the populace including both the youth and other interested citizens.
2. The BMSDC shall formulate a comprehensive sports and development program starting from the grassroots level to develop future career and national athletes.
3. The BMSDC shall organize a coaching pool, sports officials pool and athletes' pool for continuous training and development.
4. The BMSDC shall assist in sports festivals, league competitions, "palaros" and other activities to have a year-round calendar of activities for the youth.
5. The BMSDC shall coordinate with the Department of Education and all schools and universities operating within the municipality to integrate their respective sports programs and direct the same to achieve the vision of developing career and national athletes.
6. The BMSDC shall establish a sports youth center to cater to the needs and development of the youth.
7. The BMSDC shall organize sports clinics, trainings and seminars by bringing certified sports facilitators for the youth.





B. Socio-Economic

1. The BMSDC shall formulate guidelines, rules and regulations for a youth-hiring program throughout the year
2. The BMSDC shall assist the youth in finding jobs through TESDA and the PESO Office.
3. The BMSDC shall formulate guidelines, rules and regulations for assisting the youth in establishing micro-business by providing financial assistance, training, technical and marketing assistance.
4. The BMSDC shall coordinate with Department of Social Welfare and Development Office (DSWD) on related programs and projects on behalf of the municipal government.

C. Education

1. The BMSDC shall formulate guidelines, rules and regulations in providing back-to-school programs and computer literacy for the Out-of-School Youth (OSY).
2. The BMSDC shall provide trainings and seminars for the youth.
3. The BMSDC shall formulate guidelines, rules and regulations in providing scholarships to poor but deserving students.
4. The BMSDC shall coordinate with and assist the DepEd on related programs and projects.


D. Socio-Cultural

1. The BMSDC shall formulate guidelines, rules and regulations for a cultural program to develop the youth's artistic talents.
2. The BMSDC shall organize cultural activities for the youth throughout the year.
3. The BMSDC shall organize contest and competitions to encourage the youth in developing their artistic talents.
4. The BMSDC shall coordinate with and assist the Tourism Office, DepEd and the SK Federation or related programs and projects.





E. Civic

1. The BMSDC shall formulate guidelines, rules and regulations in organizing a waste management program involving the youth to promote cleanliness in the municipality.
2. The BMSDC shall forge Memorandum of Agreements to work with the schools on civic projects for their National Services Training Program (NSTP).
3. The BMSDC shall coordinate with and assist the municipality's General Services/Property Office (CGSO), DepEd and SK Federation on related programs and projects.

SECTION 4. COMPOSITION

SECTION 5. FUNDING FOR THE PROGRAM AND THE BSMDC.
Funding for this program and for the BSMDC shall come from the municipality's 20% Development Fund and Sports Fund.







2. Make representations and to receive donations, grants-in-aid and other forms of contributions whether in cash or in kind necessary for the advancement of sports development in the Municipality.
3. Include in the municipal development program the construction and provision of adequate and high standard sports facilities, supplies and equipment with the allocation of necessary funds for the same purpose; and
4. To improve the management, maintenance and operation of sport facilities owned and under the jurisdiction of the Municipal Government.

SECTION 6. INFORMATION DISSEMINATION CAMPAIGN:


Sports development cannot be achieved without information-dissemination, documentation, research and marketing, hence, the municipality shall:


1. Maximize the use and recognize the importance of media in promoting sports development in the locality;
2. Develop a data bank, records section, and sports library which will help in the proper documentation, records management and in the conduct of research relative to sports.
3. Market sports not only to augment financial resources but to promote and enhance recognition of athletes, coaches, trainers, including sports organizations from among the members of the community;

To further bolster and enhance sports development in the Municipality, the Municipal Government in coordination with local sports organizations including private individuals and sponsors shall promote sports through the launching of sports tournaments sponsored, fully or partly, by the municipal government for events where it has greater chances of winning in the regional, national and international competitions.





SECTION 7. DOCUMENTATION: The BSMDC through its Sports Coordinator shall maintain a system of the documentation of all sports competitions participated in by athletes from the municipality whether local, regional or national. The same office, in coordination with the Public Information Office, shall be tasked to document the achievement of the said athletes through photographs, videotapes and other media for future reference.

SECTION 8. CASH INCENTIVES: The Municipal Government shall grant and provide the necessary support either monetary or otherwise to each individual athletes or organized sports association upon presentation of its sports program to be evaluated by the BMSDC.

SECTION 9. HALL OF FAME FOR BACOOR SPORTS. The Municipal Government shall establish a Hall of Fame for Bacoor Sports in honor and due recognition of athletes, both in the past and in the generations to come, who gave honor and glory for Bacoor during regional and national competitions by bringing home championship trophies and gold medals in their respective sports events.

SECTION 10. SPORTS FACILITIES, SUPPLIES AND EQUIPMENT:


The Sangguniang Bayan upon the recommendation of the BMSDC shall appropriate funds for the purchase of adequate and sufficient facilities and equipments in order to meet the needs of intensive and safe participation of both in-school and out-of-school activities concerning sports.


