MUNICIPAL ORDINANCE NO. 6

AN ORDINANCE AMENDING ORDINANCE NO. 1-S-2009 BY INCREASING THE PERIOD OF THE FRANCHISES GRANTED TO QUALIFIED TRICYCLE OPERATORS IN BACOOR TO TWO (2) YEARS INSTEAD OF ONE (1) YEAR.

WHEREAS, the Sangguniang Bayan passed Municipal Ordinance No. 01-S-2009 on 19 January 2009 entitled "*AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES WITHIN THE MUNICIPALITY OF BACOOR, CAVITE*".

WHEREAS, Section 10.1 of the said ordinance provides that "all franchises issued under this Ordinance shall only be effective for one (1) year from the date of its issuance".

WHEREAS, various tricycle operators have requested the Sangguniang Bayan to amend the afore-quoted provision of Municipal Ordinance No. 01-S-2009 by increasing the period of the franchises granted under the said legislation to two (2) years instead of one (1) year.

WHEREAS, the said request was relayed and was certified urgent by the Honorable Municipal Mayor, Strike B. Revilla.

WHEREAS, after due deliberation on the said matter, the council found the said request meritorious.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Bayan of Bacoor in special session assembled to amend Section 10.1 of Municipal Ordinance No. 01-S-2009 so that the said provision shall henceforth read as follows:

"10.1. All franchises issued under this Ordinance shall only be effective for two (2) years from the date of its issuance."

ORDAINED FURTHER, that all concerned units and departments of the Municipal Government as well as all accredited Tricycle Operators and Drivers' Association (TODA) in Bacoor, Cavite be furnished with copies of this Ordinance.

ORDAINED MOREOVER, that this Ordinance shall take effect within fifteen (15) days after it has been published in a newspaper of general circulation in Bacoor, Cavite.
