**MUNICIPAL ORDINANCE NO. 24**  
**SERIES OF 2011**

**AN ORDINANCE AMENDING SECTIONS 9, 19 AND 22 OF MUNICIPAL ORDINANCE NO. 1, SERIES OF 2009 AND FOR OTHER PURPOSES.**

*Sponsored by Councilor Reynaldo Palabrica*

**WHEREAS**, the Sangguniang Bayan passed Municipal Ordinance No. 1-S-2009 on 19 January 2009 entitled, " **AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES WITHIN THE MUNICIPALITY OF BACOOR, CAVITE.**"

**WHEREAS**, the Federation of Tricycles Operators and Drivers Associations of Bacoor, Inc. (FETODAB) formally requested the Sangguniang Bayan to amend sections 9, 19, and 22 of Municipal Ordinance No. 1-S-2009 regarding the increase of tricycle fare.

**NOW THEREFORE**, after a careful deliberation, upon motion of Councilor Reynaldo Palabrica duly approved by the Sangguniang Bayan of Bacoor, Cavite in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** to amend Sections 9, 19 and 22 of Municipal Ordinance 1-S-2009 so that the said provisions shall read as follows:

**"Section 9. Procedure.** - Hereunder are the various steps and requirement that a prospective applicant for tricycle franchise must undertake and submit before he can obtain a franchise. However, the Sangguniang Bayan reserves the right to revise the following procedural steps and documentary requirements as it deems fit, to wit:

**Step 8.** The applicant must present the official receipt issued by the Municipal Treasurer's Office to the TFRU desk/window specifically created to examine the official receipt of the applicant and to release the franchise in favor of the applicant. After examination, the TFRU personnel assigned to the said desk/window, or his assistant, must then spraypaint the following notice on the inside portion of the tricycle's decar windshield, to wit:

**BAGONG BACOORI**  
 Tapat sa Serbisyo, Nagkakaisa sa Pagbabago...

**" ANG TAMANG PAMASAHE AY P10.00 LAMANG SA UNANG 1 KILOMETRO KADA PASAHERO O P30.00 SA SPECIAL TRIP NA MAYROON LAMANG DI HIHIGIT SA 2 PASAHERO. SAMANTALANG ANG BAYAD NG SENIOR CITIZEN AT ELEMENTARY/HIGH SCHOOL STUDENT AY P8.00 LAMANG. ISUPLONG ANG ANUMANG OVERCHARGING SA BACOOR TFRU TEL. (046) \_\_\_\_\_ O KAYA SA MAYOR'S OFFICE SA TEL.NO. (046) \_\_\_\_\_ - BACOOR TFRU."**

**Section 19. Fares.** - The Sangguniang Bayan hereby empowers the TFRU to prepare the implementing rules and guidelines for tricycle fares based on routes, point of origin and their destination. Such implementing rules, however, shall be subject to the approval of the Sangguniang Bayan. Provided, that such implementing rules and guidelines must take the following into consideration:

1. Basic fare for the first kilometer of every trip coming from the terminal is **Ten Pesos (PhP10.00)** and an additional fare of **One Peso (PhP1.00)** for every succeeding kilometer from the terminal of the tricycle concerned. However, if the trip is headed towards the terminal the basic fare shall be **Ten Pesos (PhP)** for the first kilometer and **One Peso (PhP1.00)** for every succeeding kilometer going back to the terminal of the tricycle concerned.
2. A Senior Citizen passenger or person with disability (PWD) with or without a valid Senior Citizen ID or PWD ID shall be charged a fare of **Eight Pesos (PhP8.00)** for the first kilometer plus an additional **One Peso (PhP1.00)** for every succeeding kilometer. The basic fare of senior citizens for the first kilometer of every trip coming from and going back to the terminal is **Eight Pesos (PhP8.00)** and an additional fare of **One Peso (PhP1.00)** for every succeeding kilometer regardless of the destination.
3. The basic fare of primary school, high school and college students with a valid school ID shall also be charged a fare of **Eight Pesos (PhP8.00)** plus an additional **One Peso (PhP1.00)** every succeeding kilometer regardless of destination. The fare of any adult accompanying the said students shall be in accordance with paragraph of 1 of this section.
4. **Entire Paragraph 4 will be deleted**

**Section 22. Special Trips.** A "special trip" is a trip from the terminal or point of origin to the intended destination without necessarily waiting for another passenger. The tricycle driver can only collect a **fixed fare of Thirty Pesos (PhP30.00) for the whole special trip within its authorized route.** Moreover, a tricycle embarking on a special trip may not carry more than three (3) passengers per trip. "

**ORDAINED FURTHER,** that all concerned units and departments of the Municipal Government as well as all accredited Tricycle Operators and Drivers' Associations (TODA) in Bacoor, Cavite be furnished with copies of this Ordinance.

**ORDAINED MOREOVER,** that this Ordinance shall take effect within fifteen (15) days after it has been published in a newspaper of general circulation in Bacoor, Cavite.


