AN APPROPRIATION ORDINANCE AMENDING THE TITLES OF THE INFRASTRUCTURE PROJECTS UNDER THE SUPPLEMENTAL BUDGET NO. 2 OF APPROPRIATION ORDINANCE NO. 22, SERIES OF 2011.

WHEREAS, the Sangguniang Bayan passed Municipal Resolution No. 72-S-2011 and Appropriation Ordinance No. 22-S-2011 on 18 April 2011 covering the Supplemental Budget No. 2 of the Municipality of Bacoor amounting to Seventy Three Million Six Hundred Three Thousand Five Hundred Nineteen Pesos and Thirty Seven Centavos (PhP73,603,519.37).

WHEREAS, the Office of the Mayor requested the Sangguniang Bayan to change the titles of the infrastructure projects of the Appropriation Ordinance No. 22-S-2011.


NOW THEREFORE, after a careful deliberation, upon motion of Councilor Reynaldo Palabrica duly approved by the Sangguniang Bayan of Bacoor, Cavite in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** to amend some of the titles of the Infrastructure Projects of Special Purpose Appropriation of Supplemental Budget No. 2, to wit:

(1) From Landscaping and Beautification Works (Clean and Green) - PhP5,000,000.00 to **"Rehabilitation and Beautification Works for Bacoor- PhP5,000,000.00"**


(2) From Construction of Stage and covered court and Repainting of Barangay Hall Molino 1 - PhP765,000.00 to **"Construction of Stage and Repainting of Barangay Hall Molino 5 - PhP765,000.00"**.






