AN ORDINANCE CONCURRING IN THE APPOINTMENT OF MRS. EMILIE DE CASTRO AS HEAD OF THE POPULATION CONTROL SERVICES, THE ABOLITION OF THE PROPOSED POSITION OF "POPULATION PROGRAM OFFICER II" IN THE POPULATION CONTROL SERVICES, AND THE REPLACEMENT THEREOF BY THE POSITION OF "SUPERVISING ADMINISTRATIVE OFFICER".

Whereas, the Personnel Selection Board through its Resolution No. 001-2011 recommended the appointment of Mrs. Emilie De Castro (Supervising Administrative Officer) as head of the Population Control Services, the abolition of the proposed position of "Population Program Officer II" in the said office, and the replacement thereof by the position of "Supervising Administrative Officer".

Whereas, in a letter dated 7 October 2011, the Municipal Mayor appointed Mrs. De Castro as head of the Population Control Services of the municipal government in a permanent capacity with no demotion in rank and with no diminution of salaries and benefits subject to the concurrence of the Sangguniang Bayan.

Whereas, on 10 October 2011, the Honorable Mayor referred the said appointment to the Sangguniang Bayan for its concurrence and approval together with the recommendation of the PSB for the abolition of the proposed position of "Population Program Officer II" in the Population Control Services and the replacement thereof by the position of "Supervising Administrative Officer".

Now therefore, upon joint motion of all the members of the Sangguniang Bayan of Bacoor, Cavite in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** that:

Section 1. The Sangguniang Bayan concurs in the appointment of Mrs. Emilie De Castro (Supervising Administrative Officer) as head of the Population Control Services in a permanent capacity with no demotion in rank and with no diminution of salaries and benefits.
