MUNICIPAL ORDINANCE NO. 9
Series of 2012

AN ORDINANCE REQUIRING ALL TECHNICAL/VOCATIONAL SCHOOLS AND ASSESSMENT CENTERS OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BACOOR TO SUBMIT TO THE BUSINESS PERMIT AND LICENSING OFFICE AND THE SANGGUNIAN, A LIST OF THEIR COURSES/PROGRAMS AND CERTIFICATES TO OPERATE DULY APPROVED BY THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) PRIOR TO THE ISSUANCE OF A BUSINESS PERMIT.

WHEREAS, Section 16 of the Republic Act 7160, otherwise known as the Local Government Code of the 1991, gives every local government unit the right to exercise "the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective, and those which are essential for the promotion of the general welfare,"

WHEREAS, there have been complaints from students and the general public regarding technical/vocational schools offering courses and assessment centers which are not duly approved by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, there is a need for a stricter regulation at the local government level to ensure that students and the general public will not be duped and to guarantee the high quality of technical and vocational services for the general welfare of the people;

NOW THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED** by the Municipality of Bacoor, in regular session assembled that:

SECTION 1. Aside from the usual requirements for the issuance or renewal of a business permit required by law or ordinance, all technical/vocational schools and assessment centers operating within Bacoor, Cavite shall be required to submit the following documents to the Business Permit and Licensing Office (BPLO);

a.) List of courses/qualifications to be offered or currently being offered or assessed by the school or assessment centers;

b.) A certification, duly signed by the school head certifying that the courses or assessment services being offered are approved by TESDA and that the same school or assessment center has complied with TESDA



Circular No. 45, Series of 2007, or "The Omnibus Guidelines on Program Registration under the Unified TVET Program Registration and Accreditation System" (UTPRAS) and TESDA Circular No. 23 Series of 2008, or "Guidelines on Assessment and Certification under the Philippine TVET Qualification and Certification System" (PTQCS), respectively;

c.) A certified photocopy of the TESDA certificate of assessment for each course offered or qualification assessed.

SECTION 2. Prior to the approval and release of the business permit, the BPLO shall provide the Sangguniang Bayan a copy of the requirements submitted by the school or assessment center, as provided for in Section 1 hereof. The Sanggunian, through its Committee on Education, shall be given seven (7) working days to evaluate the papers submitted and shall write an official recommendation to the BPLO, and an official report to the Sanggunian on the action taken by the Committee.

SECTION 3. It shall be unlawful to approve or release the business permit of the school or assessment center without the submission of the requirements set forth under Section 1 of this Ordinance. Officials and employees of the local government who shall violate the provisions of the Ordinance shall be meted the corresponding administrative penalties pursuant to civil service rules and regulations.

SECTION 4. Technical/Vocational schools and assessment centers shall be required to post a standard signage in front of the school premises, posted in a conspicuous place in plain view of the general public, stating their course or program offering with TESDA approval. Said signage shall measure not more than seventy-five by thirty-six inches (75x36") per single registered program and forty-five by seventy-five inches (45x75") for multiple programs. The BPLO shall provide the standard text of the signage.

SECTION 5. A periodic inspection shall be conducted by the BPLO, in coordination with TESDA and the Sanggunian Committee on Education, on all technical/vocational courses and assessment centers operating within the territorial jurisdiction of the Municipality to ascertain if said schools and assessment centers comply with their respective business permits and determine if the same are only offering courses and assessing qualifications approved by the TESDA. The inspection shall also include the checking of tools and equipments and interview of the trainers, assessors and students.

SECTION 6. Permits issued to technical/vocational schools and assessment centers which shall be found to be offering courses or assessing qualifications not approved by the TESDA, in violation of the certification submitted to the BPLO, shall be immediately cancelled, without prejudice to the filing of separate criminal case against the officials of the school concerned.

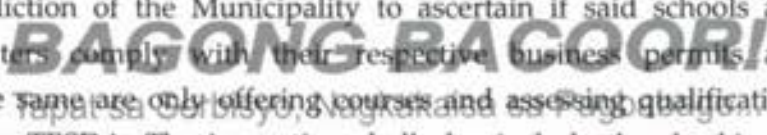

SECTION 8. SEPARABILITY CLAUSE – If for any reason, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 9. EFFECTIVITY – This Ordinance shall take effect fifteen (15) days after its posting in at least two (2) conspicuous places in Bacoor, Cavite.
