CITY ORDINANCE NO. 17

**AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ENTER INTO CONTRACTS OF AFFILIATION WITH VARIOUS EDUCATIONAL INSTITUTIONS SUBJECT TO CERTAIN LIMITATIONS.**

*Sponsored by: Hon. Avelino B. Solis, Hon. Venus D. Castro, Hon. Reynaldo D. Palabrica, Hon. Bayani M. De Leon, Hon. Catherine S. Evaristo, and Hon. Ma. Eliza Bautista*

WHEREAS, Section 8 (1) (vi) of Republic Act No. 10160 empowered the City Mayor to "represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law of ordinance";

WHEREAS, the City Health Officer, Dr. Reynaldo G. San Luis III, informed the council that the following educational institutions intend to enter into contracts of affiliation with the City Government in furtherance of their respective nursing, medical, and caregiving courses, to wit: (1) the University of Perpetual Help Las Piñas Jonelta Foundation School of Medicine for affiliation of its medical students for community health rotation program; (2) Asian Caregiving and Technology Education Center (ACTEC) for affiliation of its caregiving students; (3) Everbright International Academy for affiliation of its caregiving students in relation to its community service activities; and (4) Lyceum of the Philippines Manila and Cavite for affiliation of its nursing and caregiving students in relation to their community health rotation program.

WHEREAS, the request for affiliation of the said education institutions were related to the community health rotation programs of the same as a prerequisite for graduation of their students.

**NOW THEREFORE:**

BE IT ORDAINED upon motion of Councilor Venus D. Castro, duly seconded by all the councilors present, by the Sangguniang Panlungsod in regular session assembled **Tapat sa Serbisyo, Nagkakaisa sa Pagbabago...**

Section 1. The City Mayor is hereby authorized to sign contracts of affiliation with the following educational institutions: (1) the University of Perpetual Help Las Piñas Jonelta Foundation School of Medicine; (2) Asian Caregiving and Technology Education Center (ACTEC); (3) Everbright International Academy; and (4) Lyceum of the Philippines Manila and Cavite.

Section 2. The said contracts of affiliation should not contain any term or condition that is: (a) inimical to the interests of, or disadvantageous to, the government, (b) contrary to any provision of law, (c) entails undue

hardship to, or endangers the health and safety of, the public such as the charging of any fee by the medical, nursing, or caregiving students covered by the said contract from any patient that receives care or treatment from any of the health centers or medical facilities of the City Government, or any other harmful activity, and (d) any other provision analogous to the foregoing.

Section 3. The foregoing authority granted to the City Mayor shall also cover contracts of affiliation with other educational institutions without need of any further review or authorization from the Sangguniang Panlungsod. Provided, that the said contracts should strictly conform to Section 2 hereof. Provided further, that the authority granted herein may be revoked upon recommendation of the City Mayor.

Section 4. The Office of City Health Officer shall draft the implementing guidelines for this Ordinance subject to the approval of the City Mayor. The said implementing guidelines shall be published in a newspaper of general circulation operating in Cavite.

Section 5. Any provision of this ordinance declared unconstitutional or void shall not affect the validity of the other provisions hereof not affected by the said judicial declaration.

Section 6. This ordinance shall become after copies hereof has been posted in at least three (3) conspicuous places within the City of Bacoor for a period not less than seven (7) days.
