AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP 400,000.00) FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANTS EXPENSES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD AND THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (PHP400,000.00) FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANTS EXPENSES" UNDER THE BUDGET OF THE VICE MAYOR'S OFFICE, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2012.

WHEREAS, submitted for review and approval is the proposed re-alignment of funds under "Travelling Expenses" and "Other Maintenance and Operating Expenses" in the Office of the Sangguniang Panlungsod and Office of the Vice-Mayor covered by the Annual Budget for CY 2012;

WHEREAS, the funds to be re-aligned shall no longer be used for the Office of the Sangguniang Panlungod's budget under "Travelling Expenses" and the Office of the Vice-Mayor's budget under "Other Maintenance and Operating Expenses" considering that there are sufficient available funds to finance the operating expenses of the said offices;

Section 1.
