WHEREAS, the City Government of Bacoor through its Rural Health Units has been committed to implement the integrated and comprehensive approach to health development and to make essential goods, health and other services available to all people at affordable cost through the implementation of Republic Act No. 7875.

WHEREAS, the Office of the City Mayor endorsed a letter from the City Health Officer requesting to change the names of "Rural Health Units I and II" to the "City Health Offices I and II", to the Sangguniang Panlungsod for its review and consideration:

WHEREAS, the said health units are located at Poblacion Health Center and Floraville Health Center, respectively, both of which are accredited by the Philippine Health Insurance Corporation (PHIC) as Primary Care Benefit Provider(PCB I);

WHEREAS, the renewal of the final accreditation of the facilities of the said rural health units shall reviewed by the Department of Health on September 2013. One of the requirements for such accreditation is a Sangguniang Panlungsod Ordinance/Resolution changing the names of Rural Health Units into City Health Offices by virtue of Republic Act 10160.

NOW, THEREFORE, after careful deliberation, upon motion of Hon. Roberto R. Javier unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to change the names of "Rural Health Unit I and II" to "City Health Office I and II" located at Poblacion Health Center and Floraville Health Center, City of Bacoor, Cavite.

ORDAINED FURTHER, to furnish the City Health Office, PHIC, and other government offices concerned with copies of this Ordinance.

ORDAINED FINALLY, that this Ordinance shall be effective immediately upon posting in at least three (3) conspicuous places within the City of Bacoor.

ENACTED by the Sangguniang Panlungsod of Bacoor this 15th day of July 2013.
