2. Real II- One Hundred Thirty Two Thousand Five Hundred Sixty Pesos and 10/100 (Php132,560.10) (Please see attached Barangay Resolution and Appropriation Ordinance);
3. Panapaan VII- Two Hundred Ninety Two Thousand Nine Hundred Three Pesos and 96/100 (Php292,903.96) (Please see attached Barangay Resolution and Appropriation Ordinance);

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its 5th regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Panapaan IV, Real II, Panapaan VII and Queen's Row Central provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
