AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOOR.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Panapaan VI – Two Hundred Thirty Two Thousand Pesos (Php232,000.00) (Please see attached Barangay Resolution and Appropriation Ordinance);
2. Queens Row West- Two Hundred Eighty Seven Thousand Four Hundred Seventy Seven Pesos and 04/100 (Php 287,477.04) (Please see attached Barangay Resolution and Appropriation Ordinance);
