NOW THEREFORE, BE IT ENACTED by the Sangguniang Panlungsod in regular session duly assembled to authorize the Honorable Strike B. Revilla to sign the Community Partnership with NAVTEQ B.V. (Nokia) subject to the following conditions:

- a) No public funds shall be expended in exchange for the city government's participation in the said digital survey;
- b) The terms and conditions of the Community Partnership after it has been signed shall be subject to ratification by the Sangguniang Panlungsod;
- c) All data and information related to the City of Bacoor regardless of nature that was generated or collated as a result of the said digital survey shall be shared and given by NAVTEQ B.V. (Nokia) to the city government free of charge;
- d) NAVTEQ B.V. (Nokia) shall agree to allow the unrestrained use by the City of Bacoor of any such data in the delivery of public service;
- e) NAVTEQ B.V. (Nokia) shall guarantee that the said data shall be free of any virus, malware or any other thing that may corrupt the same, render it useless, or hamper its effective use by the city government; and
- f) All suits arising from the said Community Partnership shall be exclusively filed in the proper court of the City of Bacoor to the exclusion of any other court, tribunal, or agency.

RESOLVED LASTLY, to furnish all government offices concerned with copies of this resolution.
