**AN ORDINANCE AMENDING SECTION 1 OF THE CITY ORDINANCE NO. 21 SERIES OF 2012 ENTITLED, "AN ORDINANCE CREATING VARIOUS POSITIONS IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOR, PROVINCE OF CAVITE."**
