NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica, unanimously approved by all the councillors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled that:

Section 1. City Ordinance No. 23-S-2012 is hereby amended by changing the name of the "Bacoor Public Service Development Academy" to the "**City of Bacoor Academy of Business and Governance**".

Section 2. If, for any reason or reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effect.

Section 3. All Ordinances, resolutions, Circulars, Memorandums or Rules and regulations inconsistent with the provision of this Code are hereby repealed and modified accordingly.

Section 4. This Ordinance shall take effect immediately upon its posting in at least three (3) conspicuous places within the City of Bacoor.
