WHEREAS, the proliferation of junkshops along the main and secondary roads of the City of Bacoor contribute to the clogging of vehicular traffic and diminishes the aesthetic value of its communities. However, the existing junkshops now operating within the City of Bacoor have contributed immensely in the solid waste management program of the city government.

WHEREAS, in order to encourage operators of existing junkshops within the City of Bacoor to take an even more active role in the city's solid waste management program while not worsening the traffic management problem of the city, there is a need to prevent the establishment of new junkshops within the city by declaring a moratorium in the issuance of business permits and other permits and clearance being issued by the city government in favor of still to be established junkshops.

NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica, unanimously approved by all the councilors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled that:

Section 1. Title.—This Ordinance shall also be known as the **"Junkshop Moratorium Ordinance of the City of Bacoor"**.

Section 2. Moratorium Declaration and Coverage. — A moratorium in the issuance of new business permits and other permits and clearances in favor of operators of junkshops that are intended to be established after the date of effectivity of this Ordinance is hereby declared. **Provided that:** junkshops already operating prior to the date of effectivity of this Ordinance shall not be covered by the said moratorium. **Provided further:** that only the junkshops listed in the *Junkshop Directory* attached as **Annex "A"** hereof are exempted from this Ordinance. **Provided lastly:** that none of the junkshop operators listed in the *Junkshop Directory* shall be allowed to open branches, extensions, or annexes of their existing business that is intended to circumvent this Ordinance.

Section 3. Moratorium Lifting. — The lifting of the moratorium shall depend on the following:

- (a) the approval of the Solid Waste Management Plan of the City of Bacoor by the Department of Environment and Natural Resources;
- (b) the completion of the "Centralized Ecological Zone" as created under City Ordinance No. 2014-004 (also known as the "2014 Junkshop Regulation Ordinance of the City of Bacoor"); and
- (c) the results of the joint review to be conducted by the City Council, the City Environment and Natural

Resources Office (CENRO), and by the Provincial Government Environmental and Natural Resources Office (PG-ENRO) of the implementation of the Solid Waste Management Plan in 2016 where the advisability of lifting the moratorium shall be considered.

Section 4. Administrative Liability. – Any city employee or official who violates this Ordinance shall be meted with the following penalties subject to compliance with pertinent civil service rules and regulations:

First Offense	One (1) week suspension without pay
Second Offense	Two (2) week suspension without pay
Third Offense	Removal from the service

Section 5. Penalties. – The following penalties shall be imposed against any junkshop operator who violates this Ordinance shall be meted with the following penalties subject to the order of the proper court of law:

First Offense	Fine of Two Thousand Pesos (P2,000.00) plus 2-week temporary closure
Second Offense	Fine of Three Thousand Pesos (P3,000.00) plus 3-week temporary closure
Third Offense	Fine of Five Thousand Pesos (P5,000.00) plus permanent closure

Section 6. Separability Clause. – If, for any reason or reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effect.

Section 7. Repealing Clause. – All Ordinances, Resolutions, Circulars, Memorandums or Rules and Regulations inconsistent with the provision of this Ordinance are hereby repealed and modified accordingly.

Section 8. Implementing Rules. – The City Mayor is hereby empowered to direct the formulation of the implementing rules and guidelines of this Ordinance. Provided that the said rules and guidelines should not be contrary to the provisions hereof.

Section 9. Effectivity Clause. – This Ordinance shall take effect immediately upon its posting in at least three (3) conspicuous places within the City of Bacoor.
