3. Panapaan VI – Two Million Six Hundred Twenty Two Thousand Four Hundred Twenty Pesos (Php 2,622,420.00) (Please see attached Barangay Resolution No. 01-2014 and Appropriation Ordinance No. 1 dated October 16, 2013);
4. Molino IV – Seventeen Million Nine Hundred Seventy Three Thousand Two Hundred Sixteen Pesos (Php17,973,216.00) (Please see attached Barangay Resolution No. 01A-14 and Appropriation Ordinance No. 1 dated January 2, 2014).

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays Aniban V, Real I, Panapaan VI and Molino IV provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
