- Maliksi I – Three Million One Hundred Eighteen Thousand One Hundred Ninety Nine Pesos (Php 3,118,199.00) (Please see attached Barangay Resolution No. 01-14 and Appropriation Ordinance No. 01-14 dated February 2, 2014);

WHEREAS, Barangay Talaba IV has exceeded the 55% percentage cap for personal services of the general limitations under Section 331b of Republic Act 7160. However, the excess may be allowed provided the same shall be used only for the continued implementation of Local Budget Circular 63 dated October 22, 1996 re: Position Classification and Compensation of Bgy. Officials and Personnel.

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays Talaba IV and Maliksi I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the City Budget Officer, and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.

APPROVED UNANIMOUSLY, this 7th day of April 2014 by the Sangguniang Panlungsod of Bacoor.
