**NOW THEREFORE**, upon motion of Councilor Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the budget of the Office of the City Social Welfare and Development for the "Cash For Work" Program to "Financial Assistance for Displaced Families " as indicated above covered by Annual Budget for CY 2014.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Eight Million Pesos (PhP 8,000,000.00) for the "Financial Assistance for Displaced Families" under the budget of the Office of the City Social Welfare and Development Services for Calendar Year 2014;

Section 2. The above-mentioned amount of Eight Million Pesos (PhP 8,000,000.00) shall be re-aligned from the "Cash For Work" under the budget of the Office of the City Social Welfare and Development Services for Calendar Year 2014;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.
