16. Niog III – Three Million Seven Hundred Nineteen Thousand Six Hundred Nineteen Pesos (Php 3,719,619.00) (Please see attached Barangay Resolution No. 01-15 Series of 2015 and Appropriation Ordinance No. 01-15 dated January 7, 2015).

WHEREAS, the City Budget Officer, Mrs. Elvinia Guerrero, reported to the Sangguniang Panlungsod that the item for disbursement of appropriation in the proposed budget of the above mentioned various Barangays for Ugnayan ng Barangay at Simbahan (UBAS) should be held in abeyance pending submission by the said barangays of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes".

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays P.F. Espiritu IV, Kaingin, Tabing-Dagat, Talaba III, Talaba I, Zapote I, Daang-Bukid, Mabolo I, Molino I, Zapote IV, Ligas I, Aniban II, Habay II, Ligas II, Mambog II and Niog III provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED MOREOVER, the item for disbursement of appropriation in the proposed budget of the said various Barangays for Ugnayan ng Barangay at Simbahan (UBAS) shall be held in abeyance pending submission by the said barangays of the legal basis for the funding of the said program pursuant to Section 335 of Republic Act 7160 of the Local Government Code of 1991 which states that "no public money or property shall be appropriated or applied for religious or private purposes" to wit:

- a. Barangay P. F. Espiritu IV - Php 58,897.44;
- b. Barangay Talaba I - Php 5,000.00;
- c. Barangay Zapote IV – Php 19,248.16 and
- d. Barangay Aniban II – Php 20, 645.86

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangay P.F. Espiritu IV, Talaba I, Zapote IV and Aniban II and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
