**AN ORDINANCE CONVERTING ALL BARANGAY ROADS SITUATED WITHIN THE CITY OF BACOOR INTO CITY ROADS FOR THE PURPOSE OF AUGMENTING THE SPECIAL LOCAL ROAD FUND (SLRF) ALLOCATION OF THE CITY OF BACOOR.**

**WHEREAS**, the Special Local Road Fund (SLRF) was created pursuant to Republic Act 8794 which mandated the collection of a Motor Vehicle User's Charge (MVUC) from owners of motor vehicles, five percent (5%) of which revenues are apportioned to the SLRF to enable provincial and city governments to finance road maintenance projects.

**WHEREAS**, under the rules implementing RA 8794, a bigger portion of the SLRF is allocated to city roads as compared to barangay (or secondary) roads considering the greater volume of vehicular traffic on the former.

**WHEREAS**, most of the roads within the City of Bacoor are classified as barangay roads despite the fact that the volume of vehicular traffic on the said throughways have greatly increased in recent years.

**WHEREAS**, there is a need to convert the said roads into city roads in order to increase the SLRF allocation of the City and enable the city government to have improved financial resources to maintain the said roads.

**NOW THEREFORE**, the Sangguniang Panlungsod of the City of Bacoor hereby ordains THAT:

Section 1. The classification of all barangay roads in the City of Bacoor is hereby converted into city roads.

Section 2. The City Engineering Office is hereby directed to coordinate with the Department of Public Works and Highways (DPWH) and with other government agencies on the proper implementation of this Ordinance.
