AN ORDINANCE CREATING THE RESPONSIBLE VILLAGE LEADERS LEARNING ACADEMY (R.E.V.I.L.L.A.) HIGH SCHOOL SITUATED AT BARANGAY MALIKSI I, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF PUBLIC FUNDS FOR THE CONSTRUCTION THEREOF.

**WHEREAS**, Article XIV, Section 2 (2) of the 1987 Constitution mandates that the State shall "establish and maintain a system of free public education in the elementary and high school levels. Without limiting the natural right of parents to rear their children, elementary education is compulsory for all children of school age".

**WHEREAS**, there is a need for the construction of additional public high schools to provide for the education of the youth residing within the City of Bacoor.

**WHEREAS**, one of the areas where such a public high school should be constructed is at Barangay Maliksi I.

**WHEREAS**, the construction of the said school will make education more accessible to people residing within or near Barangay Maliksi I.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the members of the City Council duly assembled, **BE IT ORDAINED** by the Sangguniang Panlungsod that:

Section 1. A public high school to be known as the **RESPONSIBLE VILLAGE LEADERS LEARNING ACADEMY (R.E.V.I.L.L.A.) HIGH SCHOOL** is hereby created.

Section 2. The said public high school shall be constructed within Barangay Maliksi I, City of Bacoor, Cavite.

Section 3. The available funds of the City of Bacoor shall be utilized in the construction of the said school, subject to pertinent laws and government regulations.

Section 4. This Ordinance shall take effect immediately after a copy of this Ordinance has been published once in a newspaper of general circulation within the City of Bacoor.

Section 5. Let various government agencies concerned be furnished with copies of this Ordinance.
