AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various Barangays to wit:

3. P. F. Espiritu III – Forty Five Thousand Pesos (Php 45,000.00) (Please see attached Barangay Resolution No. 03-2015 Series of 2015 and Appropriation Ordinance No. 03-2015 Series of 2015 dated November 11, 2015);
4. P. F. Espiritu II – One Hundred Seventy Four Thousand Two Hundred Ninety Pesos and 71/100 (Php 174,290.71) (Please see attached Barangay Resolution No. 03-2015 Series of 2015 and Appropriation Ordinance No. 03-2015 Series of 2015 dated November 10, 2015);

WHEREFORE, after thorough deliberation on the aforementioned barangay budgets, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Real I, Mabolo II, P.
