CITY ORDINANCE NO. CO 57B-2015

AN ORDINANCE REGULATING THE USE AND OPERATION OF ELECTRIC MOTORBIKES WITHIN THE CITY OF BACOOR AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

Section 1. Short Title. This Ordinance shall also be known and referred to as the "E-Bike Regulation Ordinance of the City of Bacoor".

Section 2. Mandatory Registration of E-Bikes. The owners of all electrically charged motorbikes, including those motorbikes using alternative sources of energy such as solar panels, who are residing or doing business within the City of Bacoor are hereby required to register the said vehicle/s with the Bacoor Traffic Management Department (BTMD) within twenty (20) working days following its purchase.

Section 3. Mandatory Use of Helmets. Drivers and passengers of the vehicles mentioned in the immediately preceding section are hereby required to use safety helmets while using, operating, or riding the said motorbikes.

Section 4. Ban Against Use of Tinted Helmet Visors. The use of safety helmets with tinted visors by drivers or passengers of electrically charged motorbikes is hereby prohibited in the City of Bacoor.

Section 5. Public Information Campaign. The Public Information Office of the City of Bacoor is hereby mandated to distribute flyers and to prominently display posters in various public places within the City of Bacoor announcing the enactment of this Ordinance, the penalties imposed hereunder, and the various acts regulated under Section 2, 3, and 4 hereof. The said public information campaign shall begin ten (10) days after the publication of this Ordinance in a newspaper of general circulation within the City of Bacoor.

Section 6. Penalties. Persons who shall violate this Ordinance shall be penalized as follows:

First Offense: Payment of fine of **Three Thousand Pesos (PhP3,000.00)** by the driver of the electrically charged motorbike at the time of apprehension.

Second Offense: Payment of fine of **Four Thousand Pesos (PhP4,000.00)** by the driver of the electrically charged motorbike at the time of apprehension.

Third Offense: Payment of fine of **Five Thousand Pesos (PhP5,000.00)** by the driver of the electrically charged motorbike at the time of apprehension and his/her **imprisonment for not more than six (6) months.**

Section 7. Effectivity. This Ordinance shall take effect thirty (30) days after the Sangguniang Panlalawigan has approved it and after it has been published at least once in a newspaper of general circulation in the Province of Cavite.

Section 8. Repeal. All ordinances, resolutions, and executive orders in conflict with this Ordinance are hereby repealed or modified.
