**WHEREAS**, the general welfare clause of the Local Government Code of 1991 empowers the Sangguniang Bayan to pass ordinances that will ensure public safety.

**WHEREAS**, the incidence of bicycle theft and accidents brought about by improperly constructed sidecars attached to bicycles or motorcycles are on the rise.

**WHEREAS**, the registration of bicycles and pedicabs that are attached to bicycles or motorcycles will help eliminate the problems mentioned above.

**WHEREAS**, to address the said issues, the former Sangguniang Bayan approved Municipal Ordinance No. 9, Series of 2011, mandating the registration of bicycles and sidecars being operated in the then Municipality of Bacoor, Cavite.

**WHEREAS**, data submitted by the Bacoor Traffic and Management Department (BTMD) to the Sangguniang Panlungsod showed that very few people have complied with the said ordinance because many people find the cost of such registration (P150.00 for bicycles and P50.00 for sidecars) prohibitive.

**NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled to:

**Section 1:** Section 3 of Municipal Ordinance No. 9-S-2011 (otherwise known as the "Bicycle and Pedicab Registration Ordinance of Bacoor") is hereby amended and shall henceforth read as follows:

"Section 3: Owners of bicycles and sidecars being operated within the City of Bacoor covered by this Ordinance shall not be required to pay any registration fee if they registered on or before the last day of March of each year following the date of effectivity hereof."

**Section 2.** Any provision of any ordinance, resolution, executive order, rules and regulations and/or parts thereof

inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

**Section 3.** The unconstitutionality or invalidity of a particular provision of this Ordinance shall not affect the validity and enforceability of the remaining provisions hereof.

**Section 4.** This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation which shall immediately follow its approval by the Sangguniang Panlalawigan.
