WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of the following Barangays Aniban IV, Molino III, San Nicolas I, Daang Bukid, Molino V, Niog II, Salinas I, San Nicolas III, P.F. Espiritu II, Talaba VII, Queens Row East, Mambog II, Mambog IV, Alima, P.F. Espiritu IV, Mambog III, and Niog III, provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangay Aniban IV, Molino III, San Nicolas I, Daang Bukid, Molino V, Niog II, Salinas I, San Nicolas III, P.F. Espiritu II, Talaba VII, Queens Row East, Mambog II, Mambog IV, Alima, P.F. Espiritu IV, Mambog III, and Niog III, and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
