AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF BARANGAY BAYANAN IN THE CITY OF BACOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual General Fund Budget of Barangay Bayanan in the amount of Five Million Nine Hundred Eighty One Thousand Four Hundred Sixty Six Pesos (Php 5,981,466.00).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of Barangay Bayanan in the amount of Five Million Nine Hundred Eighty One Thousand Four Hundred Sixty Six Pesos (Php 5,981,466.00) provided that the above-mentioned barangay complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangay Bayanan and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
