WHEREAS, the Bacoor Government Center (BGC) has been the new seat of the City Government of Bacoor since it opened to the public on September 29, 2015.

WHEREAS, there is a need for a synergy of proactive planning among the incumbent elected local officials of the City of Bacoor thru constant dialogue and ready consultation that will ensure the continuance of prompt and effective delivery of services and assistance to its constituents.

WHEREAS, the new Bacoor City Hall houses, among others, the offices of the City Mayor and the Representative of the City of Bacoor to the Second Legislative District of the Province of Cavite to the House of Representatives.

WHEREAS, the representative of the City to the House of Representatives is among the members of the Local Development Council of the City of Bacoor and is actively involved in the charting and approval of future development plans for the city. Moreover, the representative of the City to the House of Representatives is mandated by law to consult with his/her constituents on various proposed bills affecting the city in particular and the nation as a whole.

WHEREAS, the establishment of a permanent office for the representative of the City to the House of Representatives within the Bacoor City Hall building would promote ease of consultation between the said official and his/her constituents and facilitate rapid coordination between the city government and its representative in the lower house of Congress with regard bills affecting the development of the City.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod that:

Section 1. A permanent office on the third floor of the New Bacoor City Hall for the representative of the City of Bacoor in the House of Representatives for the Second Legislative District of the Province of Cavite is hereby permanently established.

Section 2. Corresponding funds for the maintenance and security of the said office subject to applicable laws, rules and regulations is hereby allocated subject to availability of funds.

Section 3. This Ordinance shall take effect immediately after it has been approved by the Sangguniang Panlalawigan and after it has been published at least once in a newspaper of general circulation within the City of Bacoor, Cavite.

Section 4. In case any provision of this Ordinance is declared void or unconstitutional, such declaration shall not affect the validity and enforceability of the provisions not affected thereby.

Section 5. Any ordinance, resolution, or executive order contrary or in conflict with the provisions of this ordinance are hereby repealed or modified accordingly.
