6. Molino VII – One Million Six Hundred Eleven Thousand Four Hundred Nineteen Pesos and 11/100 (Php 1,611,419.11) (Please see attached Barangay Resolution No. 02-2016 Series of 2016 and Barangay General Appropriation Ordinance No. 02-2016 Series of 2016 dated August 24, 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Aniban II, Aniban V, Habay II, Ligas I, Zapote III and Molino VII, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.






