AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 1,500,000.00) FROM THE "FUEL, OIL AND LUBRICANTS EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "WATER EXPENSES" UNDER THE BUDGET OF THE GENERAL SERVICES OFFICE, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2016.

ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the budget of the General Services Office from the "Fuel, Oil and Lubricants Expenses" to "Water Expenses" as indicated above covered by Annual General Fund Budget for CY 2016.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of One Million Five Hundred Thousand Pesos (PhP1,500,000.00) for the "Water Expenses" under the budget of the General Services Office for Calendar Year 2016;

Section 2. The above-mentioned amount of One Million Five Hundred Thousand Pesos (PhP1,500,000.00) shall be re-aligned from the "Fuel, Oil and Lubricants Expenses" under the budget of the General Services Office for Calendar Year 2016;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.




