WHEREAS, the Bacoor Computer Clubhouse was established for the benefit of the youth without access to computer or the internet.

WHEREAS, on 26 July 2022, the Sangguniang Panlungsod passed City Resolution No. 2022-022 authorizing the City Mayor, Hon. Strike B. Revilla, to sign a License Agreement with the Massachusetts Institute of Technology (MIT) and the Museum of Science in Boston, Massachusetts, USA to enable the Bacoor Computer Clubhouse advanced computer education softwares.

WHEREAS, the said Licensing Agreement was signed by parties concerned. The City Mayor sent back a signed copy of the said Licensing Agreement for ratification by the Sanggunian.

WHEREAS, the Sanggunian reviewed the said agreement and concluded that the City Mayor did not overstep the authority that was granted to him under City Resolution No. 2022-022.
