A RESOLUTION RENAMING THE "BACOOR DISASTER RESILIENCY BUILDING" TO THE "BACOOR LEGISLATIVE AND DISASTER RESILIENCY BUILDING" SITUATED IN THE BACOOR GOVERNMENT CENTER IN THE CITY OF BACOOR, CAVITE.

WHEREAS, the city government was authorized by the Sangguniang Panlungsod to secure a loan worth P530,000,000.00 from Land Bank of the Philippines to finance the construction of an edifice supposedly to be known as the "Bacoor Disaster Resiliency Building" through City Resolution No. 2021-349 which was approved on 10 May 2021.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, reviewed the design and intended use of the said building and determined that that the uses of the said edifice can be maximized if the offices of the members of the Sangguniang Panlungsod and the personnel of the Sangguniang Panlungsod and of the Office of the Vice Mayor are transferred to the said building along with that of certain selected personnel of the Bacoor Disaster Risk Reduction and Management Office.

WHEREAS, the present offices of the members of the Sanggunian are cramped and can barely fit the said city councilors, their office staff, and their respective constituents who would visit from time to time.

WHEREAS, the office of the Sangguniang Panlungsod Secretary and Secretariat is also so severely limited that its
