**WHEREAS,** a draft Memorandum of Agreement between the Department of Health (DOH) and the city government regarding the downloading of P6,435,000.00 from the national government into the local treasury to fund the construction of the Bacoor Super Health Center in Barangay Maliksi 3 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.
