A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN DEEDS OF DONATION AND ACCEPTANCE ON BEHALF OF THE CITY GOVERNMENT OF BACOOR, CAVITE WITH: (1) ADDAS DEVELOPMENT CORPORATION, (2) ADDIO PROPERTIES INC., AND (3) NGG PROPERTIES INC.

WHEREAS, the Office of the City Mayor was approached by the registered owners of three (3) parcels of land and road lots with a total area of five thousand three hundred thirty-seven (5,337) square meters located at San Nicolas II, Bacoor City covered by the following Transfer Certificates of Title:

- Addas Development Corporation Five thousand one hundred twenty-nine (5,129) square meters covered by TCT No. 057-20155052133;
- Addio Properties Inc. ninety (90) square meters covered by TCT No. 057-2014011679; and
- NGG Properties Inc. one hundred eighteen (118) square meters covered by TCT No. T-1359727.

WHEREAS, the registered owners of the said parcels of land intend to donate the properties mentioned above exclusively for the purpose of housing the Barangay Hall of San Nicolas II, San Nicolas Elementary School, other buildings, and improvements intended for other government agencies and for other government purposes.

WHEREAS, a draft Deed of Donation and Acceptance was submitted by the Office of the Mayor to the Sangguniang Panlungsod for review and consideration.

WHEREAS, the Sangguniang Panlungsod found the terms and conditions of the said deeds of donation to be beneficial to the city government and to people of Bacoor.
