ORDINANCE NO. 1 S-96

AN ORDINANCE CLEARING THE SIDEWALKS OF ALL OBSTRUCTIONS AND PROHIBITING THE PUTTING UP OF ENCROACHMENT AND OBSTACLES AND AUTHORIZING THE REMOVAL OF ENCROACHMENT AND ILLEGAL CONSTRUCTION IN PUBLIC PLACES.

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, in regular session assembled that:

Section 1 - It shall be unlawful for any person or entity to construct any hindrance along the sidewalks that will prevent the pedestrian for its use and safety;

Section 2 - The street easement are public places which are being used for loading and unloading of passengers, in such case where there is no designated place for the purpose;

Section 3 - Any person violating this ordinance shall be penalized by a fine of not less than one thousand pesos (P1,000.00) but not more than two thousand five hundred pesos (P2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both at the discretion of the court;

Section 4 - This ordinance shall take effect ten (10) days after its approval by the Municipal Mayor and posting of copies in the bulletin board at the municipal building and in some conspicuous place in the municipality;

Section 5 - Any provision of this Ordinance found in conflict with any existing ordinance is hereby repealed.
