ORDINANCE NO. 6 S-97

AN ORDINANCE PROBIHITING THE DEFACING, BY PRINTING PAINTING, WRITING, SCRIBBLING, SCRAWLING, DRAWING, SMEARING, COLORING, STAMPING, INSCRIBING OR SPLATTERING OF WALL, SIDINGS, PARTITIONS, FENCES, GATES, DOORS OR WINDOW PANES OF BUILDINGS, EDIFICES, HOUSES OR STRUCTURES, WHETHER PUBLIC OR PRIVATE, LAMP POST, STREET SIGNS, STREETS, SIDEWALKS OR PUBLIC PROPERTY WITH CERTAIN EXEMPTIONS, AND PROVIDING PENALTY FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, in regular session assembled that:

SECTION 1. -It shall be unlawful for any person to deface, by painting, writing, scribbling, drawing, smearing, coloring, stamping, inscribing or splattering of walls, sidings, partitions, fences, gates, doors, window panes of public or private building, edifices, houses or stuctures of lamp post, street signs, street, sidewalks whether public property, except when done with consent and authority of the owner, with respect to privately owned property or when authorized by the Municipal Mayor with respect to public property;

SECTION 2.- Any person violating the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than One Thousand (P1,000.00) Pesos nor more than Two Thousand (P2,000.00) Pesos or an imprisonment of not less than ten (10) days nor more than thirty (30) days or both such fine and imprisonment at the discretion of the Court;




SECTION 3. - All ordinances, or parts thereof, inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly;


SECTION 4. - Effectivity - This ordinance shall take effect fifteen (15) days after its publication and or posting in conspicuous places.

ENACTED by the Sangguniang Bayan of Bacoor, Province of Cavite this 25th day of July 1997.


