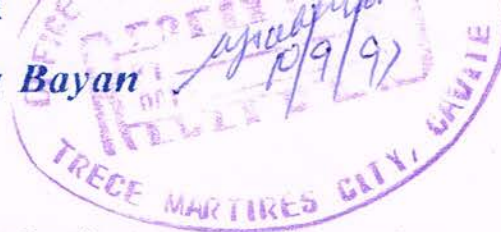

ORDINANCE NO. 7 S-97

AN ORDINANCE PROHIBITING THE ESTABLISHMENT AND OPERATION OF ANY AMUSEMENT UTILIZING SLOT MACHINES, JACKPOT MACHINES, VIDEO CARRERA, AND OTHER SIMILAR DEVICES OR CONTRIVANCES WITHIN THE JURISDICTION OF THE MUNICIPALITY OF BACOR AND PROVIDING PENALTY FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, in regular session assembled that:

SECTION 1. - It shall be unlawful for any person or juridical person to establish or operate any business or place of amusement utilizing slot machines, jackpot machines, video carrera and other similar devices or contrivances within the jurisdiction of the Municipality of Bacoor;

SECTION 2. - Any person or juridical person violating the provisions of this ordinance shall, upon conviction thereof be punished by a fine of not less than One Thousand Pesos (P1,000.00) nor more than Two Thousand Five Hundred Pesos (P2,500.00) or an imprisonment of not less than one (1) month nor more than six (6) months, likewise to customer who will be caught playing the machine will be punished by a fine of Five Hundred (P500.00) Pesos or ten (10) days imprisonment or both such fine and imprisonment at the discretion of the court;


SECTION 3. – Owner of the house or establishment wherein such slot machines, jackpot machines and video carrera were confiscated are also liable with the same penalty and the said confiscated item will be burned in public view and to be witnessed by the Chief Executive, representative from the Legislative and the Local Chief of the Philippine National Police;


SECTION 4. - All ordinances or parts thereof inconsistent with the provision of this ordinance are hereby repealed or modified accordingly;

SECTION 5. – Effectivity – This ordinance shall take effect fifteen (15) days after its publication and or posting in conspicuous places.


