ORDINANCE NO. 10-S-98

AN ORDINANCE LEVYING ENVIRONMENTAL PROTECTION AND SANITATION FEE ON EVERY HOUSEHOLD OR REAL PROPERTY UNIT OWNERS AND STALL HOLDERS AND OF ZAPOTE PUBLIC MARKET IN THE MUNICIPALITY OF BACOR, CAVITE.

WHEREAS, Chapter 1, Section 132 of the Local Government Code of 1991 has vested the Sangguniang Bayan the power to impose tax, fee or charges or to generate revenue through an appropriate ordinance;

WHEREAS, garbage collection and disposal is a prioritized basic service rendered by the Local Government of Bacoor primarily because it gravely affects the living and health condition of the citizenry;

WHEREAS, the Local Government of Bacoor, Cavite, concerned with the prevailing state of garbage collection and disposal in the municipality, has come out with an alternative plan of levying environmental protection and sanitation fee for every real property unit (household) to maximize and upgrade its garbage collection and disposal project;

WHEREAS, the enactment of this ordinance would make the residents of the municipality aware and more responsible about discarding their waste and refuse.

NOW THEREFORE;

SECTION 1. DEFINITION OF TERMS:

- A. "HOUSEHOLD" the term household shall refer to any residential building or improvement situated in the Municipality of Bacoor whether declared for realty tax purposes used as living quarters of any residents of the Municipality;
- B. "STALLHOLDER" the term stallholder shall refer to any bonafide awardee of a stall in Zapote Public Market, or his recognized transferee;

SECTION 2. FEES:

- A. Every household and/or Real Property Unit owner shall be levied a environmental protection and sanitation fee in the amount of three hundred sixty pesos (P360.00) annually.
- B. Every Stall holder shall be levied a environmental protection and sanitation fee in the amount of one thousand eight hundred pesos (P1,800.00) annually.

SECTION 3. MODE OF PAYMENT:

- A. For Households declared for realty tax purposes, the environmental protection and sanitation fee shall be incorporated to the Real Property Tax and shall be paid upon payment thereof; *simultaneously therewith*
- B. For undeclared households, owners thereof shall pay the environmental protection and sanitation fee to the Municipal Treasurer's Office;
- C. Payment may be made on a quarterly, semi-annually or annually basis subject to existing interest prescribed.

SECTION 4. PENALTY

Violation of the provision of this ordinance shall be meted a fine of not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six months or both such fine and imprisonment, at the discretion of the court. If the violator is a business establishment, the penalty shall be imposed upon the president, manager, director or persons responsible for its operation.

SECTION 5. This ordinance shall take effect fifteen days (15) after its publication in a Newspaper of general circulation in the Province of Cavite.
