ORDINANCE NO. 7 -S-99

AN ORDINANCE LEVYING ENVIRONMENTAL PROTECTION AND SANITATION FEE ON BUSINESS ESTABLISHMENTS.

WHEREAS; chapter 1, Section 132 of the Local Government Code of 1991 has vested the Sanggunian Bayan the power to impose tax, fee or charges to generate revenue through an appropriate ordinance;

WHEREAS, garbage collection and disposal is a prioritized basic service rendered by the Local Government of Bacoor primarily because it gravely affects the living and health condition of the citizenry;

WHEREAS, the Local Government of Bacoor, Cavite concern with the prevailing state of garbage collection and disposal in the municipality has come out with an alternative plan of levying environmental protection and sanitation fee on existing business establishments;

WHEREAS, the enactment of this ordinance would make the business Establishments of the municipality aware and more responsible about discarding their waste and refuse.

NOW THEREFORE;

SECTION 1. DEFINITION OF TERMS:

- A. "BUSINESS ESTABLISHMENT" THE TERM BUSINESS ESTABLISHMENT REFER TO ANY ESTABLISHMENT ENGAGED IN BUSINESS IN THE MUNICIPALITY OF BACOOR, CAVITE.

SECTION 2. FEES:

A. GARBAGE SERVICE CHARGE SHALL BE COLLECTED MONTHLY FROM EVERY PERSON (NATURAL OR JURIDICAL) ENGAGED IN BUSINESS, PROFESSION OR OCCUPATION OR ANY UNDERTAKING IN THE TOWN OF BACOOR, CAVITE IN ACCORDANCE WITH THE FOLLOWING SCHEDULE :

### SECTION 3. MODE OF PAYMENT:

- A. For Business Establishment, the environmental fee shall be incorporated to the business permit tax and shall be paid upon payment thereof ;  
For Business Establishment payment thereof shall be at the Municipal Treasurer's Office
- B. For Business Establishments, The Environmental Protection and Sanitation Fee shall be paid to the Municipal Treasurer's Office
- C. Payment may be made on a quarterly, semi-annually or annually basis subject to existing interest prescribed.

SECTION 4. PENALTY

Violation of the provision of this ordinance shall be meted a fine of not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six months, or both such fine and imprisonment, at the discretion of the court. This penalty shall be imposed upon the President, Manager, Director or persons responsible for its operation.


SECTION 5. This ordinance shall take effect fifteen days (15) after its publication in a Newspaper of general circulation in the Province of Cavite.

ENACTED on February 23, 1999 at the Municipality of Bacoor, Province of Cavite.


