ORDINANCE NO. 9-S-2002

ORDINANCE GRANTING AMNESTY ON ALL DELINQUENT REAL ESTATE TAXES.

WHEREAS, the Honorable Mayor JESSIE B. CASTILLO presented before the body a proposal to grant tax amnesty to all real property tax owners of this municipality with delinquent accounts, in order to generate revenues and increase real property tax collections;

WHEREAS, it has further been explained that said increase is necessary to lighten the burden of delinquent tax payers and the same time provide funds for the municipal development projects, provincial and barangay development projects;

WHEREAS, after a lengthy discussion on the mechanics of the proposal, it was agreed on motion of Honorable Councilor ROBERTO J. SAQUITAN duly seconded by all councilors present to grant tax amnesty;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOR, PROVINCE OF CAVITE, IN SPECIAL SESSION ASSEMBLED, THAT:

SECTION 1. The amnesty covers tax delinquencies incurred prior to December 31, 2002 only.

Handwritten signatures and notes on the left margin, including 'Rules & Privileges' and several illegible signatures.

SECTION II. The amnesty period is from **January 1, 2003 to June 30, 2003** wherein no penalty or surcharge shall be imposed on all payments full or partial during the period;

SECTION III. If the taxpayer avails of the installment scheme, the minimum payment allowable shall be **THIRTY PERCENT (30%)** of the total delinquencies due on the property less the incurred surcharges and penalties;


SECTION IV. If the taxpayers opts to pay by installment, the unpaid balance shall bear an interest of **ONE AND A HALF PERCENT (1.5%)** per month based on the diminishing balance payable up to **December 31, 2003**;

RESOLVED FURTHER to furnish copies of this Resolution to the Sangguniang Panlalawigan, Provincial Governor and Provincial Assessor of Cavite, the Honorable Municipal Mayor and Municipal Assessor of this Municipality for their information and guidance.


