



ORDINANCE NO. 01 - S - 2003

AN ORDINANCE PENALIZING JAYWALKING IN DESIGNATED AREAS OF THE MUNICIPALITY OF BACCOOR.

WHEREAS, the increase in the population of the Municipality of Bacoor brought about the increase in vehicular traffic necessitating regulation of pedestrian traffic to prevent accidents and loss of life;

WHEREAS, public safety demands that pedestrian traffic be regulated and managed;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACCOOR, PROVINCE OF CAVITE, IN SPECIAL SESSION ASSEMBLED, THAT:

SECTION 1. All pedestrians are prohibited from crossing the following thoroughfares of the municipality such as but not limited to:

- 1.1. General Evangelista Road
- 1.2. General Tirona Road
- 1.3. General Emilio Aguinaldo Highway
- 1.4. Aniban-Molino Road
- 1.5. Bayanan-Mambog Road
- 1.6. Real-Salinas Road
- 1.7. Marcos Alvares Road (Bacoor Side)

except at designated and specified areas thereof as determined by the Office of the Mayor which portions shall be marked by reflectorized paint for the guidance of the public

SECTION 2. Any person who violates the provisions of Sections 1 hereof shall be punished in accordance with the following, to wit:

- 1st Offense – Fine in the amount of ONE HUNDRED PESOS (P 100.00)
- 2nd Offense – Fine in the amount of THREE HUNDRED PESOS (P 300.00) plus four (4) hours Community Service
- 3rd Offense – Fine in the amount of FIVE HUNDRED PESOS (P 500.00) plus eight (8) hours Community Service

SECTION 3. All municipal ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 4. This ordinance shall take effect 15 days after complying with all the formalities under the law.
