ORDINANCE NO. 02 - S - 2003

AN ORDINANCE PROHIBITING THE PARKING, LOADING AND UNLOADING OF ALL TYPES VEHICLES IN DESIGNATED AREAS OF THE MUNICIPALITY OF BACOOR.

WHEREAS, the perennial bottlenecks of traffic in the Municipality of Bacoor are clogged intersections and roads brought about by unauthorized parking, loading and unloading of motorized vehicles thereat;

WHEREAS, to solve this traffic situation, it is necessary that the illegal parking, loading and unloading in strategic intersections and roads where the concentration of pedestrian and vehicular traffic are voluminous and large;

WHEREAS, public safety demands that pedestrian and vehicular traffic be regulated and managed;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOOR, PROVINCE OF CAVITE, IN SPECIAL SESSION ASSEMBLED, THAT:

SECTION 1. Vehicles of all types are prohibited to park, load or unload at any given time in all designated and specified intersections or portions of the following thoroughfares of the municipality, to wit:

- 1.1. General Evangelista Road
- 1.2. General Tirona Road
- 1.3. General Emilio Aguinaldo Highway
- 1.4. Aniban-Molino Road
- 1.5. Bayanan-Mambog Road
- 1.6. Real-Salinas Road
- 1.7. Marcos Alvares Road (Bacoor Side)

and in areas such as but not limited to schools, churches, or other places of worship and other busy areas in the municipality.

SECTION 2. The specified and designated areas where parking, loading and unloading shall be prohibited shall be determined by the Office of the Mayor will be marked by reflectorized paint for the guidance of the public.

SECTION 3. Violations of the provisions of this ordinance shall be subject to the following penalties, to wit:

1st Offense – Fine in the amount of ONE HUNDRED PESOS (P 100.00)

2nd Offense – Fine in the amount of THREE HUNDRED PESOS (P 300.00) plus four (4) hours Community Service

SECTION 5. This ordinance shall take effect 15 days after
complying with all the formalities under the law.


