Ordinance No. 11 S-2004

AN ORDINANCE AMENDING ORDINANCE NO. 3-S-2000 REGARDING THE TRICYCLE FARE WITHIN THE MUNICIPALITY OF BACOR

WHEREAS, pursuant to Art. 477 paragraph 3 (VI) of the Local Government Code, every Local Government Unit is authorized to regulate the operation of Tricycles and for this purpose of appropriate franchise to the operation thereof;

WHEREAS, pursuant to the aforesaid provision of the Local Government Code, the Land Transportation Franchising Regulatory Board has delegated the power to regulate tricycle operation to every Local Government Unit;

WHEREAS, in the interest of the riding public and the tricycle operation it is necessary to amend the tricycle fare:

WHEREAS, in the conducted public hearings of the various concerned public officials, Tricycle Operators & Drivers Association (TODA) presidents and Homeowners Association presidents, of the subdivisions concerned, in the Municipality of Bacor, it was agreed upon to amend the tricycle fare to Five pesos and fifty centavos (P 5.50) for the first one kilometer and fifty centavos (P 0.50) for every succeeding kilometer.

WHEREAS, it was also agreed upon that senior citizens can avail a one peso (P 1.00) discount from the five pesos & fifty centavos (P 5.50) basic fare. Provided that the senior citizens present their current valid identification card (I.D.).

NOW THEREFORE:

SECTION 1. The tricycle fare shall be regulated as follows:

Basic Fare for the first one kilometer:	P 5.50
Additional Fare for every Succeeding kilometers	P 0.50

SECTION 2. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 3. This ordinance shall take effect fifteen (15) days after its publication.




