ORDINANCE No. 5 - S - 2004

AN ORDINANCE REGULATING "BIYABEROS" DOING BUSINESS IN ZAPOTE PUBLIC MARKET AND IMPOSING CHARGES FOR THEIR USE AND OCCUPATION OF PORTION OR PORTIONS THEREOF IN THE CONDUCT OF THEIR BUSINESS.

WHEREAS, Zapote Public Market is a haven of "*biyaberos*" from nearby municipalities of the Province of Cavite bringing herein their fresh produced and goods such as vegetables, fruits, poultry, and other farm products which they sell at a very competitive price or almost below the prevailing market price ;

WHEREAS, due to this strategic location of Zapote Public Market, consumers not only from the Municipality of Bacoor as well as nearby towns and cities of Cavite and the Metropolitan Manila Areas regularly flock here to do their marketing, thus the lucrative business of the "*biyaberos*" continue to flourish;

WHEREAS, the continued business operation of the "*biyaberos*" is anachronistic to the newly opened two-storey Zapote Public Market as they conduct their business in a chaotic system contrary to the order being espoused in this new market;

WHEREAS, in order to remedy these situation, it is necessary that the business operation of the "*biyaberos*" be regulated in order to inculcate in them the virtue of order and sanity, thus it is paramount that specific area in Zapote Public Market be designated where they can conduct their business and trade and to impose appropriate charges and fees necessary therefore;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOOR, PROVINCE OF CAVITE, IN A SESSION ASSEMBLED, THAT:

SECTION 1. A specific place in Zapote Public Market is hereby designated where the "*biyaberos*" can continue in their trade or business and where they shall remain so unless otherwise changed by the Municipal Mayor for this purpose the latter is hereby allowed and authorized to make the necessary designation after discussion thereof with the concerned people;

SECTION 2. A charge/fee is hereby imposed to the "*biyaberos*" for transacting business inside the Zapote Public Market, graduated as follows, to wit:

Section 2.a. One Hundred Pesos (P 100.00) per day for Jeepneys;

Section 2.b. One Hundred Fifty Pesos (P 150.00) per day for Mini Buses;

Section 2.c. Two Hundred Pesos (P 200.00) per day for Trucks;


SECTION 3. Time of operations of all "*biyaberos*" shall be strictly limited from 1:00 P.M. to 3:00 A.M. only;

SECTION 4. All "*biyaberos*" must collect all their waste in plastic garbage containers and dispose the same in the market's garbage disposal area before they leave the market

SECTION 5. All municipal ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly;

SECTION 6. This ordinance shall take effect 15 days after complying with all the formalities under the law.
