AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO III AMOUNTING TO FOUR MILLION TWO HUNDRED FOURTEEN THOUSAND THREE HUNDRED FORTY FOUR PESOS AND 46/100 (Php 4,214,344.46).

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Molino III in the amount of Four Million Two Hundred Fourteen Thousand Three Hundred Forty Four Pesos and 46/100 (Php 4,214,344.46). Attached is the Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated May 3, 2017.
