## CITY ORDINANCE NO. CO 33-2017 Series of 2017

AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOOR.

WHEREAS, Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

WHEREFORE, after thorough deliberation the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, HEREBY ORDAINED AS IT IS HEREBY ORDAINED, to approve the Supplemental Appropriation of Barangays San Nicolas III, Daang Bukid and Panapaan IV, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
