AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY SALINAS II AMOUNTING TO EIGHT HUNDRED THIRTEEN THOUSAND NINE HUNDRED EIGHTY PESOS (PHP 813,980.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Salinas II in the amount of Eight Hundred Thirteen Thousand Nine Hundred Eighty Pesos (Php 813,980.00).
