**CITY ORDINANCE NO. CO 36-2017**  
**Series of 2017**

**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY HABAY II AMOUNTING TO ONE MILLION SEVENTY TWO THOUSAND NINE HUNDRED EIGHTY TWO PESOS AND 07/100 (PHP 1,072,982.07) OF THE CITY OF BACOOR, PROVINCE OF CAVITE.**
