AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY SAN NICOLAS I AMOUNTING TO EIGHT HUNDRED FORTY SIX THOUSAND FOUR HUNDRED SIXTY PESOS AND 67/100 (PHP 846,460.67) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay San Nicolas I in the amount of **Eight Hundred Forty Six Thousand Four Hundred Sixty Pesos And 67/100 (Php 846,460.67)**. Attached is the Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 01-2017 Series of 2017 dated July 11, 2017.
