AN ORDINANCE REVERTING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "CONSULTANCY SERVICES (URBAN PLANNING CONSULTANCY/PLANNING ADVISORY SERVICES)" UNDER THE BUDGET OF THE CITY MAYOR'S OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2017.

WHEREAS, submitted for review and approval are the proposed reversion of funds under the "Other Maintenance & Operating Expenses" to "Consultancy Services (Urban Planning Consultancy/Planning Advisory Services)" under the budget of the City Mayor's Office covered by the Annual General Fund Budget for Calendar Year 2017;

NOW THEREFORE, upon motion of Hon. Venus D. De Castro unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the reversion of funds under the budget of the Office of the City Mayor from the "Other Maintenance & Operating Expenses" to "Consultancy Services (Urban Planning Consultancy/Planning Advisory Services)" as indicated above covered by Annual General Fund Budget for CY 2017.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of Five Hundred Thousand Pesos (PhP500,000.00) for the "Consultancy Services (Urban Planning Consultancy/Planning Advisory Services)" under the budget of the Office of the City Mayor for Calendar Year 2017;

Section 2. The above-mentioned amount of Five Hundred Thousand Pesos (PhP500,000.00) shall be reverted from the "Other Maintenance & Operating Expenses" under the budget of the Office of the City Mayor for Calendar Year 2017;

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. —This Appropriation Ordinance shall take effect upon its approval.
